Last year the West Valley – Mission Community College District lost over 2,000,000. dollars per year in base funding because of a failure in enrollment management. This year, many more millions in future funding are threatened. A mistake in construction management may cost the District 60 million dollars of state approved renovation money for Mission College and threatens Measure H bond funds. Labor relations have been at crisis levels for two years; morale in the District is at an all time low.

The West Valley – Mission Community College District has wonderful facilities and many dedicated and talented faculty and staff but the District is in need of new leadership that is strong and positive.
